Additional details relating to the baseline emissions calculations:

The baseline inventory does not cover scope 3 emissions.

The data for year 2022 covers the following scope 3 categories: employee commuting, business travel and upstream fuel - and energy-related activities.

Calculation of upstream transportation and distribution, waste generated in operations and downstream transportation and distribution have not been made for 2022. The reason for this is that we have historically not collected the data needed for those calculations. During 2024, Attends will complete a corporate carbon footprint covering scope 1, 2 and all applicable scope 3 categories.

EMISSIONS REDUCTION TARGETS

In order to continue our progress to achieving Net Zero, we have decided to calculate our corporate carbon footprint and set targets validated by the Science Based Targets initiative.

Our current targets are:

- Annual sourcing of 100% renewable electricity.
- Annual sourcing of 100% renewable district heating.
- Convert backup heating system from fossil-based to renewable by 2027.
- Calculate a complete corporate carbon footprint in 2024.
- Set science-based targets for 2030 in 2024.

CARBON REDUCTION PROJECTS

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2015 baseline. The carbon emission reduction achieved by these schemes equate to 1742,6 tCO $_2$ e, a >85% reduction against the 2015 baseline and the measures are in effect when performing the contract.

- Change to 100% renewable electricity.
- Recycling of heat from process air.
- Change to LED lighting in production, warehouse and office areas.

The following initiatives are completed, but not included in the emission reduction above:

- Nordic Swan Ecolabel certification for our major product groups.
- Certified environmental product declarations (EPD) for our major product groups.
- Beyond value chain mitigation of remaining scope 1 and 2 emissions since 2021.
- Signing up to SBTi.
- Introduction of 30% PCR in selected bags.

In the future, we hope to implement further measures, such as:

- Calculating total carbon footprint including scope 1, 2 and 3.
- Setting SBTi targets.
- Converting emergency power to renewable fuel for 100% renewable energy use on site (current result 99.8% renewable).
- 50% PCR in bags.
